“Qualitative Data Analysis”: Course Overview

Qualitative data analysis (QDA) involves both a disciplined use of intuition and introspection as well as a systematic sense-making of various forms of “data” (e.g., field notes based on participant observation, interviews, photographs, or documents). There are many ways to produce the coherent stories that are the end result of qualitative data analysis. To date, however, qualitative researchers have been better at writing about the dilemmas and tensions that arise in field work or in representing the research than they have been at elucidating the steps in between. Thus, although analysis occurs at every phase of qualitative inquiry, this course will focus primarily on the middle steps of the QDA process.

Across the eight modules in this course, I discuss a variety of tools, strategies, and heuristic devices—but provide no magic solutions or guaranteed recipes. I emphasize the need for, and importance of, ongoing reflexivity as well as offer a pragmatic, flexible, and iterative approach to QDA. My examples draw inspiration primarily from ethnography, reflexive thematic analysis, narrative analysis, and counter-storytelling.
